They have chosen Perlas Court #90 as the name for this new court. *Perlas* means pearl in the Filipino language. The Court will meet at The Shrine Center in Shoreline on the 4<sup>th</sup> Saturday of the month.

The Grand Court of Wahington has reserved the Scottish Rite Building in Everett, for August 3, 2024, to Institute, Initiate, Constitute and Install Perlas Court and its Members. If you are a Grand Court Floor Officer, you will be receiving a letter from me in the next week or so concerning these Ceremonies.
